

RESOLUTION NO. 22-10-112

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING THE PURCHASE OF TWO (2) SCAG CHEETAH II 61" REAR DISCHARGE LAWN MOWERS FOR THE VILLAGE PUBLIC WORKS DEPARTMENT FROM GREEN THUMB PALM BEACH BY PIGGYBACKING THE FLORIDA SHERIFF'S ASSOCIATION CONTRACT NO. FSA20-EQU18.0; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE NECESSARY DOCUMENTS; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Islamorada, Village of Islands (the "Village") is in need of two (2) new lawn mowers for the Village Public Works Department to replace the current Toro 72 mower, which is no longer reliable due to its age and diminished reliability, as well as providing a new mower to the new roadway crew member added during FY 2021-2022; and

WHEREAS, \$28,000.00 was included within the Village's adopted FY 2022-2023 Capital Projects Fund budget for the purchase of two (2) new Scag lawn mowers for the Public Works Department; and

WHEREAS, the Village desires to piggyback and utilize the Florida Sheriff's Association Contract #FSA20-EQU18.0 and accept the competitive bid submitted by Green Thumb Palm Beach in response thereto for the purchase of two (2) Scag Cheetah 61" rear discharge lawn mowers for use by the Public Works Department; and

WHEREAS, the Village Council desires to approve the purchase of the two (2) Scag Cheetah 61" rear discharge lawn mowers from Green Thumb Palm Beach at a cost not to exceed the prices set forth in Exhibit "A" attached hereto; and

WHEREAS, the Village Council finds that the purchase of the two (2) Scag Cheetah 61" rear discharge lawn mowers for the Public Works Department is in the best interest of the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS: Section 1. **Recitals.** The above

recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. Approval of Piggyback Purchase. The Village Council hereby approves the piggyback of the Florida Sheriff's Association Contract #FSA20-EQU 18.0 and accepts the bid submitted by Green Thumb Palm Beach for the purchase of two (2) Scag Cheetah 61" rear discharge mowers for the Village Public Works Department, at a cost not to exceed Twenty-Five Thousand Seven hundred and Fifty-eight dollars with no cents (\$25,758.00) as set forth in Exhibit "A" attached hereto.

Section 3. Authorization of Village Officials. The Village Manager and/or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

Section 4. Execution of Documents. The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and authorized to implement the terms and conditions of any documents necessary to effectuate the purchase.

Section 5. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds for the purchase.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
