

RESOLUTION NO. 22-08-88

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, ACCEPTING THE GRANT AWARD FROM THE MONROE COUNTY TOURIST DEVELOPMENT COUNCIL ("TDC") FOR LIBRARY BEACH PARK INCLUSIVE PLAYGROUND PROJECT; APPROVING THE GRANT AGREEMENT BETWEEN MONROE COUNTY, FLORIDA AND ISLAMORADA, VILLAGE OF ISLANDS TO PROVIDE REIMBURSEMENT FUNDING FOR THE PROJECT FROM THE TDC DURING FISCAL YEAR 2022-2023; AUTHORIZING THE VILLAGE MAYOR TO EXECUTE THE AGREEMENT; AUTHORIZING VILLAGE OFFICIALS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE AGREEMENT; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, Islamorada, Village of Islands (the "Village"), offers its residents and tourists Library Beach Park, located at Mile Marker 81.5 bayside behind the Islamorada Branch Monroe County Library, open to the public from 8:00 a.m. to 5:00 p.m. every day; and

WHEREAS, the playground equipment has deteriorated, primarily from the salt air and harsh weather conditions of the tropical environment; and

WHEREAS, inclusive play spaces and parks welcome people and especially children of all abilities to play, learn and grow together by creating inclusive areas featuring activities; and

WHEREAS, the benefits of inclusive play areas are far-reaching as they are also a welcome resource for parents with disabilities, and an aging caregiver population who want to interact with the children in their care; and

WHEREAS, in April 2022, the Village applied to the Monroe County Tourist Development Council (the "TDC") requesting \$246,960.00 FY 2023 Capital Project funding Library Beach Park Inclusive Playground Project (the "Project"); and

WHEREAS, in June 2022, the TDC approved the Village's application of funding for the full amount requested; and

WHEREAS, the grant Award Agreement, Contract ID#2845 (the "Agreement"), requires execution by the Village Mayor and transmittal to the TDC by August 29, 2022, prior to execution by the Monroe County Board of County Commissioners after its October 2022 meeting; and

WHEREAS, the Village Council wishes to approve the Agreement attached hereto as Exhibit "1"; and

WHEREAS, the Village Council finds that acceptance of the grant and approval of the Agreement is in the best interest of the Village and its residents.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The above recitals are true and correct and incorporated into this Resolution by this Reference.

Section 2. **Acceptance of Grant and Approval of Agreement.** The Village Council hereby accepts the grant award from the TDC and approves the Agreement between Monroe County and the Village for reimbursement of costs for the Project, attached hereto as Exhibit "1", together with such non-material changes as may be acceptable to the Village Manager and approved as to form and legality by the Village Attorney.

Section 3. **Execution of Agreement.** The Village Mayor is authorized to execute the Agreement on behalf of the Village, to execute any other required agreements and/or documents to implement the terms and conditions of the Agreement and to execute any extensions and/or amendments to the Agreement, subject to the approval as to form and legality by the Village Attorney.

Section 4. **Authorization of Village Officials.** The Village Manager and/or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms

and conditions of the Agreement.

Section 5. Authorization of Funds Expenditure. Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to implement the terms and conditions of the Agreement.

Section 6. Effective Date. This Resolution shall become effective immediately upon its adoption.
