

**RESOLUTION NO. 22-05-34**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, APPROVING THE PURCHASE  
OF GRINDER PUMP PARTS FROM F. J. NUGENT & ASSOCIATES,  
INC., RATIFYING OTHER EXPENDITURES INCURRED FROM F. J.  
NUGENT & ASSOCIATES, INC. TO DATE, AND AUTHORIZING  
ADDITIONAL PARTS PURCHASES THROUGH THE END OF FY  
2021-2022; AUTHORIZING THE VILLAGE MANAGER TO  
EXPEND BUDGETED FUNDS; APPROVING A WAIVER OF  
COMPETITIVE BIDDING; AND PROVIDING FOR AN EFFECTIVE  
DATE**

**WHEREAS**, as part of development and maintenance of its central wastewater collection and transmission system, Islamorada, Village of Islands (the "Village"), has retained the services of F. J. Nugent & Associates, Inc. ("Nugent"), on a project-by-project basis to install, repair, and maintain wastewater system grinder pumps; and

**WHEREAS**, Nugent is a sole-source vendor of the Village for purchase of grinder pumps, grinder pump parts, and other specialized parts and equipment due to their supply of specified E-1 grinder pumps and parts; and

**WHEREAS**, the Village would like to purchase grinder pump parts from Nugent in the sum of \$45,398.90 (Exhibit "A") to receive and have on hand before hurricane season begins; and

**WHEREAS**, the Village has spent an additional \$61,091.72 on parts purchases from Nugent in FY 2021-2022 through April 30, 2022 (Exhibit "B"); and

**WHEREAS**, the Village estimates it will need to purchase an additional \$50,000.00 in parts through the remainder of FY 2021-2022, which ends on September 30, 2022; and

**WHEREAS**, pursuant to Section 2-327 of the Village's Code of Ordinances relating to the Village's purchasing guidelines, purchases of or contracts for materials, supplies, equipment, improvements, or services where the total amount expended is \$25,000.00 or more shall be awarded by the Village Council; and

**WHEREAS**, the Village Council of Islamorada, Village of Islands (the "Village Council") finds that approval of the purchase at Exhibit "A", ratification of other purchases from Nugent at Exhibit "B", approval of additional parts purchases in the amount of \$50,000.00 through fiscal year end, and waiver of competitive bidding for the purchases are in the best interest of the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Expenses.** The Village Council hereby approves and ratifies the following: 1) purchase of grinder pump parts included on Exhibit "A" from Nugent in the amount of Forty-Five Thousand Three Hundred Ninety-Eight and 90/100 Dollars (\$45,398.90), 2) purchase of additional parts in FY 2021-2022 through April 30, 2022, in the amount of Sixty-one Thousand Ninety-one and 72/100 Dollars (\$61,091.72); and 3) purchase of an additional Twenty-five Thousand and no/100 Dollars (25,000.00) in parts from Nugent through September 30, 2022.

**Section 3. Authorization of Village Officials.** The Village Manager and/or his/her designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of purchases.

**Section 4. Authorization of Fund Expenditure.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to implement the terms and conditions of the purchases.

**Section 5. Waiver of Competitive Bidding.** In accordance with Section 2-328(1) and (3) of the Village Code, the Village Council waives the competitive bidding provisions of the Village Code for these purchases.

**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption. Motion to adopt by Councilman Mark Gregg, second by Mayor Pete Bacheler.
