

RESOLUTION 17-03-16

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING THE REMOVAL OF “NO PARKING” SIGNS ADJACENT TO THE OLD HIGHWAY FROM APPROXIMATELY MILE MARKER 81.2 TO 81.8; AUTHORIZING VILLAGE OFFICIALS TO IMPLEMENT THE TERMS AND CONDITIONS OF THIS RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Islamorada, Village of Islands (the “Village”) has installed “No Parking” signs in the grassy section of the Village right-of-way northwest of Old Highway on Upper Matecumbe Key between the Hurricane Monument, located at approximately Mile Marker 81.8, and the Green Turtle Inn, located at approximately Mile Marker 81.2; and

WHEREAS, the intent of the “No Parking” signs is to restrict vehicles from parking on the Florida Keys Overseas Heritage Trail (the “Trail”) that was formerly located northwest of the Old Highway along the aforementioned area; and

WHEREAS, during improvement projects by the Florida Department of Transportation (“FDOT”) completed in 2016, the Trail was moved to an adjacent area of the Old Highway right-of-way at the request of the Village to allow for a future parking project; and

WHEREAS, the existing “No Parking” signs are no longer necessary to protect the Trail from vehicles; and

WHEREAS, the Village Council finds that removing the “No Parking” signs in the aforementioned area is in the best interest of the Village and its residents.

NOW THEREFORE BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Removal of No Parking Signs. The Village Council of Islamorada, Village of Islands hereby approves the removal of the “No Parking” signs from the grassy section

of Village right-of-way northwest of Old Highway on Upper Matecumbe Key between the Hurricane Monument, located at approximately Mile Marker 81.8, and the Green Turtle Inn, located at approximately Mile Marker 81.2

Section 3. Authorization of Village Officials. The Village Manager and/or his designee are hereby authorized to take all actions necessary to implement the terms and conditions of this Resolution.

Section 4. Effective Date. This Resolution shall become effective immediately upon its adoption.


