

RESOLUTION 23-08-91

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, AMENDING RESOLUTION
NOS. 04-11-67 AND 15-05-42 REGARDING THE SCHEDULE
FOR VILLAGE COUNCIL MEETINGS AND PROVIDING FOR AN
EFFECTIVE DATE**

WHEREAS, pursuant to Section 5(8) of the Village Charter of Islamorada, Village of Islands, Florida ("Village"), the Village Council adopted Resolution Nos. 04-11-67 and 15-05-42, thereby establishing the time and location of regular Village Council meetings; and

WHEREAS, the Village Council desires to amend Resolution Nos. 04-11-67 and 15-05-42 to modify the days of regular Village Council meetings.

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

Section 1. **Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

Section 2. **Change of Schedule.** Section 1 of Resolution No. 04-11-67 is hereby amended to read as follows:

"That the Village Council shall meet the second every third Thursday of the month as well as the immediate preceding Tuesday beginning on June 18, 2015 through September 30, 2015 at 5:30 p.m., at Islamorada Founders Park at 87000 Overseas Highway, Islamorada, Village of Islands, Florida for the purpose of considering the business and items of the Village Council and shall hold such other additional meetings as established by the Village Council pursuant to Section 5(8) of the Village Charter. Meetings shall conclude no later than 10:00 p.m. unless a majority of the Council votes to continue. All continuances shall be

limited to one-half hour increments. If the meeting should fall on a legal holiday or such other date the Village Council determines necessary, the Village Council may, by motion, reschedule or cancel any such meeting."

Section 3. Effective Date. This Resolution shall become effective October 1, 2023.




