

RESOLUTION NO. 24-11-130

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, ELECTING TO USE THE
UNIFORM METHOD OF COLLECTING NON-AD VALOREM
SPECIAL ASSESSMENTS LEVIED WITHIN THE VILLAGE
BEGINNING WITH THE TAX BILL ISSUED IN NOVEMBER 2025
FOR THE CANAL 147 RESTORATION PROJECT; STATING A
NEED FOR SUCH LEVY; PROVIDING FOR THE MAILING OF THIS
RESOLUTION; AND PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, Islamorada, Village of Islands, Florida (the "Village"), is contemplating the imposition of special assessments for the provision of operation and maintenance costs of an air curtain for canal restoration and water quality improvements at Canal 147 on Lower Matecumbe Key, with the legal description and boundaries of the real property subject to the levy attached hereto as Exhibit "A"; and

WHEREAS, the Village intends to use the uniform method for collecting non-ad valorem special assessments for the cost of providing canal water quality improvements and services, and neighborhood improvements and infrastructure to property within the incorporated area of the Village as authorized by section 197.3632, Florida Statutes, as amended, because this method will allow such special assessments to be collected annually commencing in November 2025, in the same manner as provided for ad valorem taxes; and

WHEREAS, the assessments are necessary in order to have the property owners of the properties that receive the benefit of canal restoration programs also pay for ongoing operations and maintenance of the canal restoration methods; and

WHEREAS, the Village held a duly advertised public hearing prior to the adoption of this Resolution, proof of publication of such hearing being attached hereto as Exhibit "B".

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

Section 1. The above recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. Commencing with the Fiscal Year beginning on October 1, 2025, and with the tax statement mailed for such Fiscal Year and continuing thereafter until discontinued by the Village, the Village intends to use the uniform method of collecting non-ad valorem assessments authorized in section 197.3632, Florida Statutes, as amended, for collecting non-ad valorem assessments for the cost of providing canal dredging improvements and services, and neighborhood improvements and infrastructure. Such non-ad valorem assessments shall be levied within the incorporated area of the Village. A legal description of such area subject to the assessment is attached hereto as Exhibit "A" and incorporated by reference.

Section 3. The Village hereby determines that the levy of the assessments is needed to fund the cost of operations and maintenance for the canal restoration project and neighborhood improvements and infrastructure performed on Canal 147 within the incorporated area of the Village.

Section 4. Upon adoption, the Village Clerk is hereby directed to send a copy of this Resolution by United States mail to the Florida Department of Revenue, the Monroe County Tax Collector, and the Monroe County Property Appraiser by January 10, 2025.

Section 5. This Resolution shall take effect immediately upon adoption.





Islamorada, Village of Islands, Florida (the "Village") hereby provides notice, pursuant to section 197.3632(3)(a), Florida Statutes, of its intent to use the uniform method of collecting non-ad valorem special assessments to be levied within the incorporated area of the Village, for the cost of providing canal restoration and water quality improvements and services, and neighborhood improvements and infrastructure at Canal 147 on Lower Matecumbe Key, commencing for the Fiscal Year beginning on October 1, 2025 and continuing until discontinued by the Village. The Village will consider the adoption of a resolution electing to use the uniform method of collecting such assessments authorized by section 197.3632, Florida Statutes, at a public hearing to be held at 5:30 p.m. on November 19, 2024 at the Founders Park Community Center, 87000 Overseas Highway, Islamorada, Florida. Such resolution will state the need for the levy and will contain a legal description of the boundaries of the real property subject to the levy.
