**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, APPROVING THE PURCHASE
OF A 2025 FORD EXPLORER FOR THE VILLAGE BUILDING
DEPARTMENT FROM DUVAL FORD BY PIGGYBACKING THE
FLORIDA SHERIFF'S ASSOCIATION CONTRACT NO. FSA 24-VEL-
32; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE
NECESSARY DOCUMENTS; AUTHORIZING THE VILLAGE
MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING
FOR AN EFFECTIVE DATE**

WHEREAS, Islamorada, Village of Islands (the "Village") is in need of a new vehicle for the Village Building Department; and

WHEREAS, \$60,000 was included in the Village's adopted FY 2024-2025 Capital Projects Fund budget for the purchase of a new vehicle for the Building Department; and

WHEREAS, the Village desires to piggyback and utilize the Florida Sheriff's Association Contract No. FSA 24-VEL-32 and accept the competitive bid submitted by Duval Ford in response thereto for the purchase of 2025 Ford Explorer for use by the Building Department; and

WHEREAS, the Village Council desires to approve the purchase of the 2025 Ford Explorer from Duval Ford at a cost not to exceed the prices set forth in Exhibit "A" attached hereto; and

WHEREAS, the Village Council finds that the purchase of the 2025 Ford Explorer for the Building Department is in the best interest of the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The above recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. Approval of Piggyback Purchase. The Village Council hereby approves the piggyback of the Florida Sheriff's Association Contract No. FSA 24-VEL-32 and accepts the bid submitted by Duval Ford for the purchase of a 2025 Ford Explorer for the Village Building Department, at a cost not to exceed Forty-Six Thousand One hundred and Thirty-Four dollars and no cents (\$46,134.00) as set forth in Exhibit "A" attached hereto.

Section 3. Authorization of Village Officials. The Village Manager and/or her designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

Section 4. Execution of Documents. The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and authorized to implement the terms and conditions of any documents necessary to effectuate the purchase.

Section 5. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds for the purchase.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.




