

## **RESOLUTION NO. 25-09-75**

### **A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AUTHORIZING AN ADDITIONAL NOT-TO-EXCEED AMOUNT OF \$5,000.00 FOR REPAIRS AND MAINTENANCE OF THE SURVEILLANCE CAMERA SYSTEM AND NETWORK WITH MONIFI TECHNOLOGY GROUP LLC; PROVIDING FOR WAIVER OF COMPETITIVE BIDDING; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, On May 7, 2024, the Village Council approved Resolution 24-05-34 awarding the Surveillance Camera System Project to Monifi Technology Group LLC following a competitive Request for Proposals (RFP) at a total cost of \$50,075.00, which included installation at the Administrative Center, Plantation Yacht Harbor Marina, Ron Levy Aquatic Center, and Public Works area; and

**WHEREAS**, This project was designed to replace aging and disjointed systems with a unified and centralized surveillance camera system capable of expansion and adaptability to future infrastructure needs; and

**WHEREAS**, On February 11, 2025, the Village Council approved Resolution 25-02-11 expanding the surveillance camera system to the six Wastewater Stations in Islamorada, bringing the total project cost in Fiscal Year 2024–2025 to \$75,745.00; and

**WHEREAS**, Staff has identified a critical need for ongoing repairs and maintenance of the surveillance camera system and associated network infrastructure, including work at Fire Rescue Stations 19 and 20 and at Founders Park to support Parks and Recreation Point-of-Sale (POS) operations; and

**WHEREAS**, Monifi Technology Group LLC has performed additional network cabling and surveillance system work for the Village during the current fiscal year, and cumulative expenditures

have exceeded the \$25,000.00 threshold authorized under the Village Manager's purchasing authority; and

**WHEREAS,** Monifi Technology Group LLC was originally selected through a competitive RFP process and has since provided continuity of service in designing, installing, and maintaining the surveillance system, and it is in the best interest of the Village to waive additional competitive bidding requirements for this scope of work; and

**WHEREAS,** Staff recommends authorizing an additional not-to-exceed amount of \$5,000.00 to Monifi Technology Group LLC for repairs and maintenance of the surveillance camera system and network.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Fiscal Year Purchases and Expenditures.** The Village Council hereby authorizes an additional not-to-exceed amount of \$5,000.00 for repairs and maintenance of the surveillance camera system and network with Monifi Technology Group LLC.

**Section 3. Authorization of Village Officials.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds for purchases from IAC for Fiscal Year 2024-2025.

**Section 4. Execution of Documents.** The Village Council hereby waives the requirement for additional competitive bidding for this scope of work, as Monifi Technology Group

LLC was originally selected through a competitive RFP process and is uniquely positioned to continue providing these services.

**Section 5.**     **Authorization of Fund Expenditure.** Notwithstanding the limitations set forth in the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to Monifi Technology Group for camera repairs and network installation.

**Section 6.**     **Effective Date.** This Resolution shall take effect immediately upon adoption.
