

**RESOLUTION NO. 25-09-78**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, APPROVING THE PURCHASE  
OF APEX EXTRICATION STRUT KITS FROM SOUTHERN RESCUE  
TOOLS FOR THE VILLAGE FIRE RESCUE DEPARTMENT;  
AUTHORIZING THE VILLAGE MANAGER TO EXECUTE  
NECESSARY DOCUMENTS; AUTHORIZING THE VILLAGE  
MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING  
FOR AN EFFECTIVE DATE**

**WHEREAS**, Islamorada, Village of Islands (the "Village") needs a new extrication struts for the Village Fire Rescue Department; and

**WHEREAS**, funds in the amount of \$28,000.00 for the purchase of a new extrication struts for the Village Fire Rescue Department were budgeted in the Fire Rescue Capital Outlay budget in the adopted FY 2024-2025 Capital Projects Fund; and

**WHEREAS**, the Village Council of Islamorada, Village of Islands (the "Village Council") desires to approve the purchase of three (3) APEX Extrication Struts from Southern Rescue Tools at a cost not to exceed the prices set forth in Exhibit "A" attached hereto; and

**WHEREAS**, the Village Council finds that the purchase of three (3) sets of APEX Extrication Struts for the Fire Rescue Department is in the best interest of the Village and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Purchase.** The Village Council hereby approves the purchase of three (3) sets of APEX Extrication Struts for the Village Fire Rescue Department, at a cost not to exceed Thirty Thousand Two Hundred Fifty-Eight (\$30,258.00), as set forth in Exhibit "A" attached hereto.

**Section 3. Authorization of Village Officials.** The Village Manager and/or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

**Section 4. Execution of Documents.** The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and authorized to implement the terms and conditions of any documents necessary to effectuate the purchase.

**Section 5. Authorization of Fund Expenditure.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to purchase the fire equipment.

**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption.
