**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA APPROVING ADDENDUM TO
CONTRACTUAL SERVICES AGREEMENT FOR SOLID WASTE,
YARD WASTE AND RECYCLING COLLECTION AND DISPOSAL
SERVICES WITH ISLAND DISPOSAL COMPANY; AUTHORIZING
VILLAGE MANAGER AND VILLAGE ATTORNEY TO
EXECUTE THE ADDENDUM; AUTHORIZING THE VILLAGE
MANAGER TO IMPLEMENT THE TERMS AND
CONDITIONS OF THE ADDENDUM; AND PROVIDING FOR
AN EFFECTIVE DATE**

WHEREAS, Island Disposal Company (the "Contractor") and Islamorada, Village of Islands (the "Village") entered into a certain Contractual Services Agreement for Solid Waste, Yard Waste and Recycling Collection and Disposal Services (the "Agreement") effective January 1, 2024; and

WHEREAS, the parties desire to enter into the Addendum to the Agreement (the "Addendum") to modify the performance bonds requirements, which is attached hereto as Exhibit "1"; and

WHEREAS, the Village Council finds that approval of the Addendum is in the best interest of the Village and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The above recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. Approval of Addendum. The Village Council of Islamorada, Village of Islands, hereby approves the (a) reduction in the performance bond amounts as set forth in the Addendum; and (b) provision requiring execution of the now statutorily required noncoercion affidavit, attached hereto as Exhibit 1.

Section 3. Authorization of Village Officials. The Village Manager and/or his designee and the Village Attorney are authorized to execute and deliver the Addendum in substantially the same form as set forth in Exhibit 1 hereto.

Section 4. Authorization of Implementation. The Village Manager is authorized to implement the terms and conditions of the Addendum to the Agreement.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption

This is an addendum to the certain Contractual Services Agreement for Residential and Commercial Solid Waste, Yard Waste and Recycling Collection and Disposal Services (the "Agreement") is made and entered into as of July 6, 2023, by and between Island Disposal Company, a Florida Corporation ("CONTRACTOR"), and Islamorada, Village of Islands, Florida (the "VILLAGE").

WHEREAS, the Contractor has requested the Village for a reduction in the amount of its required performance bond; and


WHEREAS, the Village has determined that it is in the best interest of the Village to allow for such reduction in amount.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is mutually acknowledged, it is agreed that:

1. The Performance Bond in the amount of \$1,000,000.00 as required by Section 20.1 of the Agreement is hereby authorized to be reduced to the amount of \$500,000.00.
2. The CONTRACTOR has complied with the requirements of Section 787.06(13), Florida Statutes, by having an officer or other authorized representative of the CONTRACTOR execute the Affidavit attached hereto as exhibit "A", which attests, under penalty of perjury, that it does not use coercion for labor or services, as defined in Section 787.06, Florida Statutes



Exhibit "A"

Affidavit Attesting to Noncoercive Conduct for Labor or Services

As a nongovernmental entity executing, renewing, or extending a contract with a government entity, Contractor is required to provide an affidavit under penalty of perjury attesting that Contractor does not use coercion for labor or services in accordance with Section 787.06(13), Florida Statutes.

As defined in Section 787.06(2)(a), coercion means:

1. Using or threatening to use physical force against any person;
2. Restraining, isolating, or confining or threatening to restrain, isolate, or confine any person without lawful authority and against her or his will;
3. Using lending or other credit methods to establish a debt by any person when labor or services are pledged as a security for the debt, if the value of the labor or services as reasonably assessed is not applied toward the liquidation of the debt, the length and nature of the labor or service are not respectively limited and defined;
4. Destroying, concealing, removing, confiscating, withholding, or possessing any actual or purported passport, visa, or other immigration document, or any other actual or purported government identification document, of any person;
5. Causing or threatening to cause financial harm to any person;
6. Enticing or luring any person by fraud or deceit; or
7. Providing a controlled substance as outlined in Schedule I or Schedule II of Section 893.03 to any person for the purpose of exploitation of that person.

As an officer or other authorized representative of the Contractor authorized to sign on behalf of Contractor, I certify that Contractor does not use coercion for labor or services in accordance with Section 787.06.

Under penalties of perjury, I declare that I have read the foregoing Affidavit and that the facts stated in it are true.
