

**RESOLUTION NO. 25-10-102**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING THE PURCHASE OF A 2026 FORD F-550 XL FROM DUVAL FORD FLEET SALES FOR THE VILLAGE FIRE RESCUE DEPARTMENT; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE NECESSARY DOCUMENTS; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Islamorada, Village of Islands (the "Village") needs a heavy tow vehicle for the Village Fire Rescue Department; and

**WHEREAS**, funds in the amount of \$122,500.00 for the purchase of a new vehicle for the Village Fire Rescue Department were budgeted in the Fire Rescue Capital Outlay budget in the adopted FY 2025-2026 Capital Projects Fund; and

**WHEREAS**, the Village desires to piggyback the Florida Sheriff's Association/Florida Association of Counties & Florida Fire Chiefs' Automotive Contract #FSA23-VEL-21-RO and accept the competitive bid submitted by Duval Ford Fleet Sales in response thereto for the purchase of 2026 Ford F-550 Pickup Truck for the Fire Rescue Department; and

**WHEREAS**, the Village Council of Islamorada, Village of Islands (the "Village Council") desires to approve the purchase of the 2026 Ford F-550 Work Truck from Duval Ford Fleet Sales at a cost not to exceed the prices set forth in Exhibit "A" attached hereto; and

**WHEREAS**, the Village Council finds that the purchase of the 2026 Ford F-550 Work Truck for the Fire Rescue Department is in the best interest of the Village and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Purchase.** The Village Council hereby approves the piggyback of the Florida Sheriff's Association/Florida Association of Counties & Florida Fire Chiefs' Automotive Contract #FSA23-VEL-21-RO and accepts the bid submitted by Duval Ford Fleet Sales for the purchase of a 2026 Work Truck for the Village Fire Rescue Department, at a cost not to exceed Ninety Two Thousand Seventy Six Dollars Fifteen Cents (\$92,076.15), as set forth in Exhibit "A" attached hereto.

**Section 3. Authorization of Village Officials.** The Village Manager and/or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

**Section 4. Execution of Documents.** The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and are authorized to implement the terms and conditions of any documents necessary to effectuate the purchase.

**Section 5. Authorization of Fund Expenditure.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to purchase the fire equipment.

**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption.




