

**ORDINANCE NO. 25-10**

**AN ORDINANCE OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA,  
AMENDING CHAPTER 2 "ADMINISTRATION", SECTION 2-332;  
PROVIDING FOR SEVERABILITY; PROVIDING FOR INCLUSION IN THE  
CODE; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, the Village Council of Islamorada, Village of Islands (the "Village Council") has a number of boards, committees and commissions of the Village that requires the Village Council to appoint members periodically; and

**WHEREAS**, the Village Council desires to provide for a uniform date for the appointment, removal and terms of members to various boards, committees and commissions of the Village; and

**WHEREAS**, the Village currently has boards, committees and commissions, but no uniform date for the appointment of such members in the Village Code; and

**WHEREAS**, the Village Council finds that providing a uniform appointment date and amending any inconsistent provisions in the Village Code is in the best interests of the Village and its residents.

**NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1.**    **Recitals.** The above recitals are true and correct and are incorporated herein by this reference.

**Section 2.**    **Amendments to the Code.** Chapter 2 entitled "Administration", is hereby amended as set forth herein:

**ARTICLE V. – Village Board, Committees and Commissions.**

**Sec. 2-332. Appointment to Board, Committee or Commission.**

Each member of a board, committee or commission shall be appointed by a majority vote of the village council. Appointments, when available, shall be made during a regular village council meeting in May of each year. In the event that the regular village council meeting in May is cancelled, or appointments are otherwise unable to be made, the term of the board members shall not expire until appointments are made at the next regular village council meeting.

**Section 3.**     **Repeal of Conflicting Provisions.** The provisions of the Village of Islamorada Code and all Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

**Section 4.**     **Severability.** The provisions of this Ordinance are declared to be severable and if any sentence, section, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sentences, sections, clauses or phrases of the Ordinance but they shall remain in effect it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

**Section 5.**     **Inclusion in the Code.** It is the intention of the Village Council and it is hereby ordained the provisions of this Ordinance shall become and be made part of the Village of Islamorada Code, that sections of this Ordinance may be renumbered or re-lettered to accomplish such intentions, and that the word "Ordinance" shall be changed to "Section" or other appropriate word.

**Section 7.**     **Effective Date.** This Ordinance shall become effective immediately upon adoption.
