

ORDINANCE NO. 25-15

AN ORDINANCE OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AMENDING CHAPTER 50, ARTICLE III OF THE VILLAGE CODE TITLED "TRAFFIC AND VEHICLE SPEED ZONES", SECTION 50-53 "SPEED ZONES; ESTABLISHED", TO CREATE A MAXIMUM SPEED ZONE OF TWENTY MILES PER HOUR FOR VEHICLES OPERATED ON CORTEZ DRIVE; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 316.189, Florida Statutes, permits municipalities to establish reasonable speed limits of twenty (20) or twenty-five (25) miles per hour in residential zoning districts after an investigation determines that such speed limit is reasonable and in conformity with criteria promulgated by the Department of Transportation ("FDOT");

WHEREAS, in 2005, the Monroe County Engineer on behalf of Islamorada, Village of Islands ("Village") conducted an investigation in accordance with, and utilizing the procedures set out by, applicable law and the promulgated rules of the Florida Department of Transportation;

WHEREAS, this investigation demonstrated that maximum speed zones of twenty (20) miles per hour and twenty-five (25) miles per hour are reasonable speeds for certain local streets within the residential districts of the Village, excluding any County or State roads within the Village;

WHEREAS, Ordinance 05-10 established maximum speed zones in selected residential district streets; and

WHEREAS, in the intervening years, additional residential streets have been added to the twenty (20) miles per hour speed zones; and

WHEREAS, in 2018, the Village commissioned an Islamorada Traffic and Safety Study; and

WHEREAS, the 2018 study makes note of the increase in automobile accidents from the years 2011-2015; and

WHEREAS, various residents in and around Cortez Drive have approached the Village about creating a safer environment as a result of numerous speed-related incidents; and

WHEREAS, the Village believes that the reduction in speed on Cortez Drive will likely lead to a corresponding reduction in speed-related incidents – thereby creating a safer environment for those traveling on and living near Cortez Drive; and

WHEREAS, the Village now desires to include Cortez Drive in the list of residential district streets previously established in section 50-53 of the Village Code; and

WHEREAS, the Village Council finds that reducing the speed limit on Cortez Drive from 25 miles per hour to 20 miles per hour is in the best interest of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Amendments to the Village Code. Chapter 50 of the Village Code titled "Streets, Sidewalks and Other Public Places" is hereby amended by specifically revising Article III, "Traffic and Vehicle Speed Zones", Section 50-53 to read as follows:¹

ARTICLE III "Traffic and Vehicle Speed Zones."

Section 50-53. Speed Zones; Established.

(a) As authorized by F.S. § 316.189(1), there is hereby established a maximum speed limit of 25 miles per hour for all streets in residence districts of Islamorada, Village of Islands except for the following streets where the maximum speed limit shall be 20 mph:

- (1) Bayview Drive, Lower Matecumbe Key
- (2) Buttonwood Lane, Lower Matecumbe Key
- (3) Willow Lane, Lower Matecumbe Key
- (4) Sapodilla Drive, Lower Matecumbe Key
- (5) Columbus Drive, Lower Matecumbe Key
- (6) Cortez Drive, Lower Matecumbe Key
- (7) Jerome Avenue, Upper Matecumbe Key
- (8) Atlantic Street, Upper Matecumbe Key
- (9) Matecumbe Avenue, Upper Matecumbe Key
- (10) Gulf Street, Upper Matecumbe Key
- (11) Bay Street, Upper Matecumbe Key
- (12) Palm Avenue, Upper Matecumbe Key
- (13) Industrial Drive, Upper Matecumbe Key
- (14) Johnson Road, Upper Matecumbe Key
- (15) Beach Road, Upper Matecumbe Key
- (16) Preston Street, Upper Matecumbe Key
- (17) North Carroll Street, Upper Matecumbe Key

(b) Speed zones shall be posted in accordance with F.S. § 316.189(3).

Section 3. Repeal of Conflicting Provisions. The provisions of the Village Code of Ordinances and all Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed.

Section 4. Inclusion in the Code. It is the intention of the Village Council, and it is hereby ordained the provisions of this Ordinance shall become and be made part of the Village of Islamorada Code, that sections of this Ordinance may be renumbered or re-lettered to accomplish such intentions, and that the word "Ordinance" shall be changed to "Section" or other appropriate word.

Section 5. Severability. The provisions of this Ordinance are declared to be severable and if any sentence, section, clause or phrase of this Ordinance shall for any reason be held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining sentences, sections, clauses or phrases of the Ordinance but they shall remain in effect it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any part.

Section 5. Effective Date. This Ordinance shall become effective immediately upon adoption.
