

RESOLUTION NO. 18-11-110

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING THE PURCHASE OF EXTRICATION EQUIPMENT FROM MUNICIPAL EMERGENCY SERVICES (MES) FOR THE VILLAGE FIRE RESCUE DEPARTMENT; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE NECESSARY DOCUMENTS; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; PROVIDING FOR A WAIVER OF COMPETITIVE BIDDING; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Islamorada, Village of Islands (the “Village”) is in need of new extrication equipment for the Village Fire Rescue Department; and

WHEREAS, the purchase of extrication equipment for the Village’s Fire Rescue Department was budgeted for in the adopted FY 2018-2019 Capital Projects Fund Budget; and

WHEREAS, the Village desires to accept the quote of the sole source vendor for Florida, Municipal Emergency Services (MES), for the purchase of extrication equipment; and

WHEREAS, the Village Council desires to approve the purchase of extrication equipment from Municipal Emergency Services (MES) at a cost not to exceed the prices set forth in the quote dated 10/12/18 and attached as Exhibit “A” hereto; and

WHEREAS, the Village Council finds that the purchase of the extrication equipment for the Fire Rescue Department and waiver of competitive bidding is in the best interest of the Village and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. Approval of Purchase. The Village Council hereby approves the sole source purchase for Hurst rescue equipment and accepts the quote submitted by Municipal Emergency Services (MES) for the purchase of extrication equipment for the Village Fire Rescue Department, at a cost not to exceed Sixty Thousand Six Hundred Eighty Dollars (\$60,680.00).

Section 3. Authorization of Village Officials. The Village Manager and/or his/her designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

Section 4. Execution of Documents. The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and authorized to implement the terms and conditions of any documents necessary to effectuate the purchase.

Section 5. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to purchase the fire equipment.

Section 6. Waiver of Competitive Bidding. In accordance with Section 2-328(2) of the Village Code, the Village Council approves the waiver of the competitive bidding purchasing provision of the Village Code for the purchase the extrication equipment.

Section 7. Approval of Budget Amendment. The Village Council hereby approves a budget amendment to reflect use of fund balance in the Capital Projects Fund in FY 2018-2019 for the purchase of the extrication equipment directly and without entering into a financing arrangement.

Section 8. Effective Date. This Resolution shall take effect immediately upon adoption.


