

RESOLUTION NO. 18-02-12

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA APPROVING A PROPOSAL FROM TRIANA FENCE, INC. FOR NEW FENCING ON VILLAGE-OWNED AND ALONG VILLAGE-MAINTAINED PROPERTY; AUTHORIZING VILLAGE OFFICIALS TO IMPLEMENT THE TERMS AND CONDITIONS OF THE PROPOSAL; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE AN AGREEMENT FOR THE REQUESTED SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, as a result of damage sustained by Hurricane Irma, Islamorada, Village of Islands (the “Village”) needs to replace a total of 3,987 feet of fencing on Village-owned properties and along Florida Department of Transportation (“FDOT”) rights-of-way within the Village; and

WHEREAS, Triana Fence, Inc. (“Triana – Fence”) was the lowest bidder in response to requests for bids from three (3) contractors; and

WHEREAS, the Village desires to utilize Triana – Fence for the replacement and installation of fencing as set forth in the proposal attached hereto as Exhibit “A”; and

WHEREAS, the Village Council finds that approval of the cost proposal from Triana – Fence is in the best interest of the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. Approval of Proposal. The Village Council hereby accepts and approves the cost proposal from Triana – Fence for the requested services, as set forth in the proposal attached hereto as Exhibit “A”.

Section 3. Authorization of Village Officials. The Village Manager and/or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the Proposal.

Section 4. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to implement the terms and conditions of the Proposal.

Section 5. Execution of Proposal. The Village Manager is authorized to enter into and execute and Agreement with Triana – Fence in accordance with the Proposal attached hereto as Exhibit "A", to execute any required agreements and/or documents to implement the terms and conditions of the Proposal and to execute any extensions and/or amendments to the Proposal, subject to the approval as to form and legality by the Village Attorney.

Section 6. Effective Date. This Resolution shall take effect immediately upon adoption.
