

**RESOLUTION NO. 20- 12-110**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING THE RECOMMENDATION OF THE ITB 20-13 EVALUATION COMMITTEE FOR THE PURCHASE OF A 2021 25' PATHFINDER VESSEL WITH TRAILER AND THE PURCHASE OF A YAMAHA 300 HP OUTBOARD MOTOR FOR LAW ENFORCEMENT SERVICES; AUTHORIZING THE VILLAGE MANAGER AND VILLAGE ATTORNEY TO ENTER INTO AN AGREEMENT FOR THE PURCHASE; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Islamorada, Village of Islands' (the "Village") utilizes the Monroe County Sheriff's Office (MCSO) Law Enforcement Department to perform law enforcement activities within the Village; and

**WHEREAS**, MCSO patrols the waters of Islamorada and performs marine patrol, boating regulation enforcement and rescue activities; and

**WHEREAS**, in September 2002 the Village purchased a 2002 22' Angler vessel for use by MCSO deputies to patrol the waters of Islamorada; and

**WHEREAS**, on July 20, 2020, while on patrol, the vessel was damaged and subsequently declared a total loss by the insurance company; and

**WHEREAS**, on October 26, 2020, the Village issued ITB 20-13 to receive competitive bids for the purchase of a new 25' Pathfinder vessel with trailer; and

**WHEREAS**, the Village Manager established an Evaluation Committee (the "Committee") to review responsive bids and make a recommendation to the Village Council for the selection of a boat dealer for the purchase; and

**WHEREAS,** the Committee reviewed the one (1) proposal received (Exhibit "A") using the selection criteria detailed in the ITB 20-13 and recommends the purchase of a 2021 25' Pathfinder with motor and trailer from Caribee Boat Sales; and

**WHEREAS,** the Committee also recommends that the Village Council authorize funds for the purchase of a Yamaha 300 motor from Central Florida Yamaha available through State Contract for the new Pathfinder boat (Exhibit "B"); and

**WHEREAS,** the Village Council has determined that the purchase of a 2021 25' Pathfinder with trailer from Caribee Boat Sales and the purchase of a Yamaha 300 motor from Central Florida Yamaha are in the best interest of the Village and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Acceptance of Bid.** The Village Council hereby approves the selection of Caribee Boat Sales for the purchase of a 2021 25' Pathfinder vessel with motor and trailer.

**Section 3. Authorization of Village Officials.** The Village Manager and/or her designee and the Village Attorney are authorized to enter into an agreement with Caribee Boat Sales for the purchase of the vessel.

**Section 4. Authorization of Fund Expenditures.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds up to \$75,000.00 for the new boat and trailer purchase from Caribee Boat Sales for approximately \$53,000.00, the purchase of a new Yamaha

300 motor from Central Florida Yamaha for approximately \$18,500.00, and other additional costs in the amount of approximately \$3,500.00 .

**Section 5.**     **Effective Date.** This Resolution shall take effect immediately upon adoption.

**Introduction**

**Rig**

This 2500 will not be a 2020 as requested. The new model will be a 2021. As requested, instead of quoting a derig of the old boat, I quoted just rigging the new boat for an F300 supplied by Village of Islands Islamorada. As requested, I also added the trade of the F225XCA. Since Caribee does not sell used motors, we received an offer of \$10,000 from one of our wholesalers. The F225 will be derigged by Village of Islands Islamorada and traded in before the new boat is ordered to be sure the trade-in value is correct.

The quote also includes derigging and re-rigging the GPS and Dome radar off of the old boat and onto the new boat. This quote includes a continental trailer, and bottom paint. Please see the following page for an itemized quote.

This Contract is between the State of Florida, Department of Management Services (Department), an agency of the State of Florida and Central Florida Yamaha, Inc., dba Boater's World Marine Center at 730 US 27 North, Lake Placid, FL 33852 (Contractor), collectively referred to herein as the "Parties."

The Department is authorized by subsection 287.042(16), Florida Statutes, "to evaluate contracts let by the Federal Government, another state, or a political subdivision for the provision of commodities and contract services, and, if it is determined in writing to be cost-effective and in the best interest of the state, to enter into a written agreement authorizing an agency to make purchases under such contract."

The Florida Fish and Wildlife Conservation Commission, competitively procured Boat Motors and Related Components, and signed contract number 18282 with the Contractor, attached hereto as Exhibit C (Master Agreement). The Master Agreement is effective July 1, 2019, and terminates on June 30, 2022. Renewal options are available.

The Department evaluated the Master Agreement, and hereby acknowledges that use of the Master Agreement as an alternate contract source contract is cost-effective and in the best interest of the State.

Accordingly, the Parties agree as follows:

**1. Term and Effective Date.**

The initial term of this Contract will become effective on July 1, 2019 or on the date the document is signed by all Parties, whichever is later, consistent with the Master Agreement, unless terminated earlier in accordance with Exhibit A (Special Contract Conditions), July 1, 2019 version, attached hereto and incorporated herein by reference.

**2. Renewal.**

Upon agreement of the Parties, this Contract may be renewed. Renewals must be in writing and are subject to the same terms, conditions, and modifications set forth in this Contract.

**3. Modifications or Additions to Master Agreement.**

As used in this document, Contract (whether or not capitalized) shall, unless the context requires otherwise, mean this document and all incorporated Exhibits, which set forth the entire understanding of the Parties and supersedes all prior agreements. All modifications to this Contract must be in writing and signed by all Parties. Amendments to the Master Agreement will be automatically incorporated into this Contract.

All Exhibits attached or listed below are incorporated in their entirety into, and shall form part of this Contract. Exhibit A modifies or supplements the terms and conditions of the Master Agreement. The Parties agree that these modifications or additions shall apply to actions between the Contractor and the State of Florida (including participating Florida agencies and eligible users). In the event of a conflict, the following order of precedence shall apply:

- a) This Contract and amendments, with the latest issued having priority.
- b) Exhibit A: Special Contract Conditions
- c) Exhibit B: State of Florida Price Sheet
- d) Exhibit C: Master Agreement

Where the laws and regulations of a state other than the State of Florida are cited or referenced in the Master Agreement, such citation or reference shall be replaced by the comparable Florida law or regulation.

**4. Purchases off this Contract.**

Upon execution of this Contract, Customers, as defined in Section 1.1 of the Special Contract Conditions (Exhibit A), may purchase products and services under this Contract using this State of Florida ACS number 26101502-19-ACS. Customers acknowledge and agree to be bound by the terms and conditions of the Master Agreement except as otherwise specified in this Contract and its Exhibits.



The purpose of this Invitation to Bid (ITB) is to solicit sealed bids from qualified Boat Dealers to provide the Village with a police patrol boat, new trailer, de-rig the existing motor and electronics on the current boat, re-rig the motor and electronics on new boat and deliver to the Village's Law Enforcement Department in Islamorada, Florida.

## **II. OBJECTIVES**

The objective of this ITB is to solicit bids for the purchase of a 2020- 25' Pathfinder boat with a new trailer, de-rig existing boat and re-rig new boat for the Village's Law Enforcement Department in accordance with the specifications detailed in the Scope of Services.

## **III. BACKGROUND AND HISTORY**

The Village is a municipality located within the Florida Keys and is comprised of four (4) islands spanning 18 linear miles. The population is approximately 6,400 and the Village has about 115 full-time employees. As a Florida municipality, the Village must operate within the guidelines of Florida Statutes relating to public records, public meetings, and Sunshine laws. The Village undergoes an annual financial audit pursuant to Florida Statutes. Additionally, the Village must follow the guidelines of its purchasing ordinance when purchasing capital, supplies and services.

The Islamorada Law Enforcement Department patrols the waters of Islamorada in the Florida Keys. Since Islamorada has both inland bay and coastal waters, the Village is in need of a replacement boat for its fleet that must be capable of operating in shallow waters and be seaworthy for off-shore responses into gulf waters. The vessel will be used for law enforcement patrol and rescue. The vessel shall be capable of continuous operation during all weather conditions which occur on the Florida Bay. These weather conditions range from calm and clear to choppy swells. It shall be designed and built to assure maximum durability and safety. The trailer shall be a double-axle for a step hull and suitable for the new vessel.

Patrol activities include, but are not limited to, educating boaters about harbor, navigation, and municipal codes and performing vessel and safety equipment inspections. Patrol shifts are typically 8-10 hour. Boating enforcement and rescue activities are performed 24-hours a day throughout the year.

The new vessel will replace the current 2002- Grand Bay 22' Angler hull. The existing 225 Yamaha 4 stroke motor from the old boat will be mounted on the new vessel.

## **IV. SCOPE OF SERVICES**

This bid is for the purchase of a new boat with trailer, de-rigging of the existing motor and electronics on the current boat, rigging the motor and electronics onto the new boat, delivery of the new boat and trailer to the Village's marina facility, warranty on the new hull and warranty on workmanship. Bids for partial services will not be accepted.

Variations to the specifications below will be considered but must be submitted for consideration as an alternative, and not as the responsive bid.

## **V. ELIGIBILITY CRITERIA**

The electronic copy should be identical to the original printed package, in natively converted PDF format and should be labeled **"2020- 25' Pathfinder Vessel for Islamorada, Village of Islands' Law Enforcement Department (ITB 20-13)."**

Bid packages must contain the following information:

1. Cover Letter introducing your firm, proposal and point of contact information, including a company history and history of building or selling vessels with the same or similar specifications to those listed
2. Cost Proposal broken down by cost of new vessel, cost of new trailer, cost of de-rigging and re-rigging motor and other equipment and delivery charge to the Village's marina facility. The Village is exempt from paying Florida sales tax.
3. Timeline for delivery of vessel, including the time to build, de-rig components on existing boat and re-rig components onto the new boat.
4. Three references from other customers who purchased similar vessels, including name of client, date of purchase and contact information. References should include any history of sales to other law enforcement agencies.
5. Warranty information on the hull and workmanship.

## VI. EVALUATION SCORING AND TIMELINE

A noticed public bid opening will be held at the Village Administrative Center. An Evaluation Committee made up of at least three Village staff members will be appointed by the Village Manager and will convene in a noticed public meeting to evaluate the bids after they are opened. Bids will be evaluated for responsiveness to the ITB and to prepare a ranking of recommendations based on a point system to the Village Council for entering into contract negotiations. Negotiations will commence with the first-ranked bidder. If the Village and the first-ranked bidder are unable to finalize a contract, then the negotiation process will move to the second-ranked bidder and so forth.

The point system for the evaluation and scoring of responsive proposals will be as follows:

Bidders should include the purchase and rigging cost of a new engine onto the new vessel. Bidders shall identify this cost separately in the bid.

Bidders shall state and identify any credits to the bid price in return for the engine on the existing boat.
